The maximum any individual may contribute is \$2,300 for the primary election and an additional \$2,300 for the general election. Couples may contribute \$4,600 for the primary election and general elections, respectively. Federal PACs may contribute \$5,000 for each election. Contributions from corporations, labor unions, federal government contractors, national banks, and foreign nations without permanent residency status are prohibited.
