Regular Meeting of the City Council via Zoom Conference on October 20, 2021, at 6:30 P.M.

The Council convened at 5:30 P.M. Councilwoman Souza made a motion, seconded by Councilwoman Johnson, to enter into executive session to discuss litigation and personnel matters at 5:31 P.M., Councilwoman Johnson made a motion, seconded by Councilwoman Souza, to exit executive session and commence the regular meeting of the City Council. The meeting began at 6:30 P.M.

1. Roll Call.

Mayor Cohn asked the City Clerk to call the roll; a quorum was present to conduct official City business.

2. <u>Draft unapproved minutes of the Regular Meeting of the City Council held October 6, 2021.</u>

Councilwoman Johnson made a motion, seconded by Councilman Stacks and unanimously carried, to adopt the minutes of October 6, 2021.

3. Presentation of the Mayor John Carey Merit Award

Mayor Cohn presented the 2021 Mayor John Carey Merit Award to Councilman Richard Mecca, recognizing decades of civil contribution to the City of Rye. Councilman Mecca has served in many volunteer capacities, including years on the City Council, Planning Commission, and as a volunteer firefighter.

Councilman Mecca thanked the Mayor, Council and community for their support during his service to the City.

4. Post-Ida Storm update.

Mayor Cohn began by stating that although more time had passed since Ida, many residents are still coping with the after-effects of the storm. He discussed the actions that the City continued to provide to residents. Mayor Cohn noted that he had been in touch with many senior elected officials on behalf of the City, and there have been many helpful conversations (the

Governor's Office of Storm Recovery and DASNY). There have been discussions with the City's Harrison and Mamaroneck neighbors in an effort to work together to mitigate future flooding disasters. Discussions have been ongoing with Senator Schumer's office to obtain federal funding for the damage. The City has received information from the Army Corps of Engineers regarding the state's mitigation initiatives.

City Manager Usry stated that the City was well underway with filings on the City's damage to buildings, sidewalks and streets. Research continues to be done about the damage, and 12 to 14 locations throughout the City have been identified. He reminded everyone that the month had been the rainiest on record. He said that the City was engaging outside engineers to assist the City, and said that regular maintenance of the catch basins is imperative. The staff is doing what it can to remediate and prevent future flooding. He reminded the residents that federal filing for FEMA had been pushed to December to report the damage.

5. Bid Award for Contract 2021-02 Manhole Rehabilitation Project.

Ryan Coyne, Superintendent of Public Works, introduced all of the projects, which will remedy various infrastructure needs throughout the City.

Councilwoman Souza made a motion, seconded by Councilman Stacks and unanimously carried, to adopt the following resolution:

WHEREAS, as part of the Save the Sound v. City of Rye, et al. Settlement Decree, the City of Rye is required to undergo significant and continuing manhole repair and replacement efforts; and

WHEREAS, the City went out to bid for the work as described in the Consent Decree; and

NOW, THEREFORE, BE IT RESOLVED, that the City Council awards Contract #2021-02 "Manhole Rehabilitation Project" to Con-Tech Construction Technologies in the amount of Five Hundred Ninety Thousand One Hundred Eighty-two Dollars (\$590,182); and

BE IT FURTHER RESOLVED, that the City anticipates that it will be reimbursed for these costs partially through grants and the remaining costs can be reimbursed through bond proceeds or other sources of revenue.

BE IT FURTHER RESOLVED, that the City anticipates that it will be reimbursed for these costs partially through grants and the remaining costs can be reimbursed through bond proceeds or other sources of revenue.

9. <u>Bid Award for Contract 2021-06 Central Avenue Pump Station.</u>

Councilwoman Souza made a motion, seconded by Councilman Stacks and unanimously carried, to adopt the following resolution:

WHEREAS, as part of the Save the Sound v. City of Rye, et al. Settlement Decree, the City of Rye is required to replace the Central Avenue Pump Station Project; and

WHEREAS, the City went out to bid for the work as described in the Consent Decree; and

NOW, THEREFORE, BE IT RESOLVED, that the City Council awards Contract #2021- 06 "Central Avenue Pump Station Project" to ELQ Industries, Inc. in the amount of One Million Two Hundred Twenty Six Thousand Four Hundred Sixty Seven Dollars (\$1,226,467); and

BE IT FURTHER RESOLVED, that the City anticipates that it will be reimbursed for these costs partially through grants and the remaining costs can be reimbursed through bond proceeds or other sources of revenue.

10. <u>Consideration of proposed revisions of the Rules and Regulations of the City of Rye</u> Police Department: General Orders #104.1.

Interim Public Safety Commissioner, Michael Anfuso, proposed revisions of the following General Order updates the Department's procedures: G.O. 104.1 Uniform Specifications, Equipment & Identification – (2018) changes made to conform to accreditation standards. Specifically the addition of "identification" to the General Order title, Addition of business cards; Update to outer vest carriers."

Councilwoman Johnson made a motion, seconded by Councilman Mecca and unanimously carried by the Council to approve the proposed revisions of the Rules and Regulations of the City of Rye Police Department: General Orders #104.1.

11. Open the public hearing for October 6, 2021 to create a new local law, Chapter 122, "Landscapers and Leaf Blower Regulations" requiring all landscapers to obtain an annual permit in order to operate as a landscaper and restrict the use of leaf blowers.

Mayor Cohn introduced the topic. He stated that this would be a proposed update of the leaf blower law. Enforcement has been an issue, and this law seeks to address the current shortcomings in the City code as it is written. City Manager Usry added that this would address the use of gas powered leaf blowers and the noise issues associated with it.

Councilwoman Souza made a motion, seconded by Councilwoman and unanimously carried, to open the public hearing to create a new local law, Chapter 122, "Landscapers and Leaf Blower Regulations" requiring all landscapers to obtain an annual permit in order to operate as a landscaper and restrict the use of leaf blowers.

Kate Briggs addressed the Council. She stated concern about the proposed legislation, as it may inhibit landscaping operations. She also expressed concern over people not putting back trees in order to avoid the leaf blower issues.

Bob Zahm, Rye resident, asked about the timeframe of the proposed changes. He also asked about the enforcement operations. For example, if someone witnesses a leaf blower being operated and calls the police, but by the time the police arrive at the scene, nothing will happen if the leaf blower is no longer in use.

City Manager Usry responded that enforcement would be against the company operating the blower at a residence. He stated that a violation would result in a penalty up to \$1500, which in itself may be a deterrent of use. Upon a third violation, a company would lose its annual permit, which would prevent them from operating in the City of Rye for that year.

There was general discussion about the enforcement, including possible revocation for six months, concrete fines, and the fact that the landscapers obtaining this permit would need to be licensed by Westchester County.

Robert Alexander, 90 Stuyvesant, said he applauded the Council for taking action on the issue of leaf blowers and was hopeful for a positive impact on quality of life if the law was passed. However, he felt that the law should apply to all entities without exemptions. He said that the country clubs were the biggest offenders of the gas blowers and residential neighbors need to be considered.

Leslie Winters, Rye resident, commented that she felt that residents should be able to document violations to report to the police. She expressed frustration over the fact that calls are made to the Police Department, and by the time they are addressed, the offender is no longer using the leaf blower.

Curtis Spacavento stated that the electric blowers are very difficult to use and lose battery power quickly. He felt that the priority of the police should not be enforcing leaf blowers, but tending to more pressing emergencies.

Gibb Kane, 350 Stuyvesant, 30-year Rye resident, spoke in support of taking advantage of the technology now present in leaf blowers, allowing for a lower decibel level. He said that the noise issues presented by leaf blowers in recent years had gotten worse. He played an audio clip for the Council of recent leaf blower use by a local club, heard from inside his home. He stated that the clubs should not be exempt.

Councilwoman Goddard thought it might be prudent to study the laws as they apply to clubs in other municipalities.

Councilwoman Souza made a motion, seconded by Councilwoman Goddard, to keep the public hearing open for further discussion.

12. <u>Financial update on Q3 results.</u>

Deputy Comptroller, Joseph Fazzino, gave the Council and community an update on the $3^{\rm rd}$ Quarter results.

He commented on the following:

• Sales & Use Taxes

Actual results are for the first two quarters of 2021, (December through May) Payment for the 2nd quarter was \$329,788 or 52% more than the same time period last year. The City will receive our 3rd quarter number right around budget time, however revenue for the first two months of the quarter is up 18%. Assuming the 18% for the 3rd quarter and the City receiving the same amount for the 4th quarter that it did last year, 2021 Sales tax for the year would exceed the budget by about \$700,000.

• Parking Meter Revenue

Budgeted revenue was lowered from \$436,000, to \$292,500. If the activity is the same as the final three months of 2020, this line could be about \$100,000 better than budgeted.

Parking Fines

Slightly better than budget, same as last year.

• Moving Violation Fines – through August

One the items that brought some concern during the beginning of the year, after falling short of budget by almost \$125,000 in 2020 and were down significantly during the first quarter.

However, from April through August, over \$158,000 has been collected, which is a combination of more cars being on the road and a "catch-up" for all of the cases that could not be heard in person during the pandemic. This has put this source of revenue back on track. After averaging the last few years, a small surplus of about \$25,000 can be expected.

Hotel Occupancy Taxes

Revenue for the 1st quarter and 2nd quarter (ending June 30). 1st quarter was still during Pandemic and 2nd quarter began to see an uptick but still down about 25% from pre-pandemic levels. Assuming this same type of dip for the 3rd and 4th quarters, we should still see the budget met as we were very conservative with our estimates for 2020.

• Interest Income

Still have July through September to collect. Should be down significantly, about \$45,000

• Penalties & Interest – Property Taxes (NEW)

Always conservative in our budgeting, we can expect a surplus of about \$100K, to more than offset the loss in interest income.

• Mortgage Taxes

We now have the full year worth of data for the period (October – September) In light of the current situation, the Federal Reserve recently reduced interest rates to almost zero. This, along with increased activity in the real estate market. Back in July we had said based on average results for the last two years from July through September, historically bigger months, total revenues for the year could exceed budget by \$700,000. We now know that real number will be over \$806,000.

• Building Permits

Revenues are up 96% from last year, and have exceeded the 2021 budget after only 9 months of activity. Assuming the SAME level of activity for the second half as last year, revenues would exceed the budget by \$400,000.

• State Aid Revenue Sharing – Nothing changed

Last year, State aid was cut by 20% and the City budgeted accordingly. As a result of the American Rescue Plan, state aid was restored for 2020, with the final 5% (\$60,401) received after the City closed its books, therefore being applied to 2021. The City has received the first payment of \$181,413 (15%), which is the same number we had received in all years prior to 2020. Typical receipt of the remaining 85% is in mid-December, and City staff assumes the same funding it has received for over a decade, resulting in \$302,000 in unbudgeted revenues.

• American Rescue Plan

The City has received the first half of the Federal aid package, a little over \$800,000 in July and it can expect to receive the other \$800,000 next July. This is restricted for use on Capital projects.

• Recreation Programs

Regarding camp activities, the City is operating at 50% Capacity, with certain camps not offered which has translated into 50% of budgeted revenue. With other camp programs thriving, staff would not expect the budgeted net cost of the Recreation department to be impacted.

• Employee Salaries and Payroll Taxes

This number reflects all budgeted and more importantly CONTRACTED salary and step increases through June 30. There were also UNFILLED budgeted positions as of September, leading to substantial savings through June 30 of approximately \$850,000. Some of these positions are in the process of being filled.

• Employee and Retiree Health Insurance

The 2021 Budget included a conservative estimate of 10% for increased employee and retiree healthcare costs. Actual rates for 2021 for employees were 3% and remained flat for retirees.

• Workers Compensation – 2020 Budget \$1,162,561/2020 Projection \$1,062,561

The 2021 Budget conservatively called for a 10% increase over the 2020 premium. For the 3rd straight year the City's experience rating has gone down. The 2021 premium came in 14% less than the 2020 premium and has been paid in full. Give some small additional payments for the rest of the year, the 2021 workers comp expense will come in around \$240,000 under budget.

• Contingency

The City has only used \$50,000 of the budgeted \$350,000 of contingency this year. It was used for additional funding to EMS services. Typically used for legal fees and harsh winters, we do not anticipate any additional use of contingency this year.

13. <u>Consent to City Manager's appointment of Mike Kopy to Commissioner of Public Safety.</u>

City Manager Usry explained that Article IV of the Charter states that the City Manager may appoint a Commissioner of Public Safety with Council approval. Mr. Usry introduced his choice for Commissioner of Public Safety, Michael Kopy. He stated that Mr. Kopy brings many years of leadership in police and fire. Mr. Kopy has experience both at the local level and state level.

The Council approved City Manager Usry's appointment.

City Manager Usry thanked Acting Commissioner Michael Anfuso who had stepped in with tremendous leadership over the last three months.

14. Update from Westchester Power.

Paul Presendieu, Westchester Power, gave an update to the Council and on the Community Choice Aggregation Program, as required by the Public Service Commission. He reiterated that Westchester Power is a consortium of 44 local governments. He provided an overview of the program, the sustainable aspects of it, and discussed the cost of the consortium's energy. He also discussed Community Solar. He invited the Council and community to contact him with any questions.

15. Residents may be heard on matters for Council consideration that do not appear on the agenda.

Bob Zahm, Rye resident, asked about the status of the unnecessary pole that was still on Theodore Fremd. City Manager Usry responded that two other poles had been removed in the last ten days and that he would follow up.

Suki van dijk, Rye resident, inquired about the state of the trees at Rye Golf Club, concerned that healthy trees were calling to be removed. She felt that trees were important trees, particularly with issues such as flooding.

Joseph Donley, Rye resident, inquired about financials with regard to Rye Golf Club. Mr. Usry responded that Golf Manager Jim Buonaiuto would be putting together additional clarification about the Golf Club's financials in the coming weeks. He also offered to put Mr. Donley in touch with Comptroller Fazzino to explain the financials.

Councilman Stacks commented that the Golf Commission would be further discussing the plan for the course and trees, which will have a full open process. City Manager Usry added that certain trees had issues with public safety that needed to be addressed by professionals.

16. <u>Authorization for City Manager to enter into an Inter-municipal Agreement with</u> Westchester County for the providing a Positive Youth Development Program for 2021.

City Manager Usry explained that this was an annual program. In an effort to encourage municipalities to provide Positive Youth Development Programs, the County shall reimburse the City of Rye in an amount not to exceed \$3,159 to provide Youth Council Programs as described in the attached agreement. The Agreement covers a one-year period between January 1, 2021 through December 31, 2021.

Councilwoman Johnson made a motion, seconded by Councilman Mecca, to authorize the City Manager to enter into an Inter-municipal Agreement with Westchester County for the providing a Positive Youth Development Program for 2021.

17. Bid rejection for Rye Golf Club 2021 Fairway Drainage Project.

City Manager Usry explained the Golf Club bid out a project to replace fairway drainage on holes 7, 11, & 16 at the club. Only one bid was received, which had a concerning bid well

above the pre-bid estimate. He also believed prices may be inflated right now due to COVID's impact on the supply chain for the materials involved in this project. As such, staff has requested that the Council reject this bid.

Councilman Mecca made a motion, seconded by Councilman Stacks and unanimously carried, to adopt the following resolution:

RESOLVED that the City Council rejects the bid from Con-Tech Construction Technology for the Fairway Drainage project at Rye Golf Club.

19. Adjourn until November 3, 2020 the public hearing for consideration of a petition from The Miriam Osborn Memorial Home to amend the text of the City of Rye Zoning Code Association to create new use and development standards for "Senior Living Facilities" in the R-2 Zoning District.

Mayor Cohn stated this item will be adjourned until the November 3, 2021 meeting.

- c. Consideration of a request from Longford's, to have a food truck on Elm Place in front of the store from November 2, 2021 November 4, 2021 from 1:00 pm 8:00 pm to accommodate interior repairs. The City Council will have to waive § 144-8D and G of the City Code.

CITY OF RYE

LOCAL LAW NO. FOR THE YEAR 2021

A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-C

Be it enacted by the City Council of the City of Rye as follows:

Section 1. Legislative Intent: It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the City of Rye pursuant to General Municipal Law §3-c, and to allow the City of Rye to adopt a budget for the fiscal year beginning January 1, 2022 and ending December 31, 2022 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

The City Council finds that this local law would provide the City the flexibility it may need when it adopts the 2022 budget. Thus, the City Council of the City of Rye finds that it is in the best interests of the City to enact the local law.

Section 2. Authority: This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the City Council to override the tax levy limit by the adoption of a local law approved by vote of at least sixty percent (60%) of the City Council.

<u>Section 3.</u> Tax Levy Limit Override: The City Council of the City of Rye, County of Westchester is hereby authorized to adopt a budget for the fiscal year 2022 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

Section 4. Severability: If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

<u>Section 5.</u> Effective date: This local law shall take effect immediately upon filing with the Secretary of State.

CITY OF RYE

LOCAL LAW NO. __ 2021

A local law to add a new Chapter 122 "Landscapers and Leaf Blower Regulations" of the Code of the City of Rye to set forth permit requirements for Landscaping Companies and to regulate the use of gas and electric powered leaf blowers as follows:

Section 1: Chapter 122, Landscapers and Leaf Blower Regulations

§ 122-1 Purpose.

The City Council finds that landscaping activities generate noise, disseminate dust particles and other airborne pollutants into the air and onto other nearby properties and that the use of leaf blowers specifically can increase environmental pollution. In addition, there are numerous landscaping companies providing services to properties in the City and the City Council finds that it is in the City's interest to ensure that such companies are properly licensed and are aware of the applicable regulations in the City. It is the intent and purpose of this Chapter to preserve and improve air quality, decrease the high and low-frequency noise pollution and decrease carbon and non-carbon emissions and dust particulate. It is the policy of the City to regulate the use of all leaf blowers and minimize and mitigate the harmful impacts of their use.

§ 122-2 Definitions.

As used in this chapter, the following terms shall have the meanings indicated:

LANDSCAPER – Any person, corporation, partnership or business entity of any form who tends, plants, installs, maintains, or repairs lawns, or performs general yard maintenance work or leaf collection of any kind on real property which such person or business entity does not own or at which s/he does not reside. A Landscaper shall not include landscape designers or landscape architects.

LEAF BLOWER – a portable, handheld or backpack-style device powered by fuel or electricity and used for the purpose of blowing, moving, removing, dispersing, vacuuming or redistributing leaves, dust, dirt, grass clippings, cuttings, and trimmings from trees and shrubs or any other type of litter or debris.

§ 122-3 Registration required; requirements; fee; exemption

- A. No Landscaper shall operate or provide services within the City of Rye unless the Landscaper is registered annually pursuant to this Chapter.
- B. Registration requirements.
 - 1. All Landscapers shall submit a completed registration form provided by the City Clerk and pay a nonrefundable fee in an amount to be determined by the City Council.
 - 2. The registration form, at a minimum, shall state that the landscaper has read, understands and agrees to comply with the City's leaf blower regulations and other relevant City laws and policies.

- 3. In addition, the Landscaper shall submit proof of a valid and current Westchester County Home Improvement License and such other insurance information that the City deems relevant.
- C. When the City Clerk determines that all requirements have been met, s/he shall issue a Landscaper Registration Tag, which must be placed on the rear view mirror of each vehicle the landscaper uses in the City. The Tag is not transferable.
- D. The Landscaper Registration Tag shall be valid from January 1 through December 31 each year, unless revoked.

§ 122-4 Use of Gas Powered Leaf Blowers Prohibited.

Effective January 2023, during the time that leaf blower use is permitted, only electric blowers shall be permitted. Gas powered leaf blowers are prohibited at all times.

§ 122-5 Maximum Sound Pressure [db(A)] and hours of operation of leaf blowers

- A. Effective January 2023, leaf blowers (electric only) shall have a maximum permitted intensity of 65 db(A). Effective immediately, all other lawn equipment, including, but not limited to, outdoor vacuum cleaners shall have a maximum permitted intensity of 85 db(A).
- B. Use of lawn equipment, including, but not limited to, leaf blowers and outdoor vacuum cleaners is permitted only between 8:00 a.m. and 6:00 p.m. weekdays and 10:00 a.m. and 4:00 p.m. on weekends and holiday. The permitted intensity and hours described in this subsection will apply to leaf blowers during months when the use of leaf blowers is permitted.
- C. The use of leaf blowers shall be prohibited between May 1 and September 30 every year.
- D. The head of the Rye Department of Public Works may permit the use of leaf blowers from May 1 to September 30 for a period of time not to exceed fourteen (14) days after significant storm events or during other emergency situations.
- E. Additional rules for any person operating a leaf blower between the dates of October 1 and April 30 are as follows:
 - 1. No leaf blower shall be operated simultaneously on the same lot with any other type of machine-powered lawn equipment.
 - 2. Two or more leaf blowers shall not be operated simultaneously except in R-1 Residence Districts as indicted on the City of Rye Zoning Map.

- F. This section shall not apply to the following entities and activities: municipal, schools, religious institutions, membership clubs, golf courses, hospital and retirement communities, cemeteries, and driveway/road paving and sealing activities, except that any leaf blower use shall be minimized to the maximum extent practicable in proximity to residences.
- G. Moving leaves or yard debris to City streets, public property, storm drains or abutting lots is prohibited at all times.

§ 122-6 Enforcement.

The provisions of this chapter shall be enforced by the City of Rye Police Department or the City of Rye Building Department.

§ 122-7 Penalties for offenses.

- A. The following parties shall have committed a violation of this laws if it is not complied with:
 - (1) The party operating the leaf blower; and
 - (2) The party who employed the person to operate the leaf blower at the time of violation; and
 - (3) The party who owns the property where the violation occurs.
- B. Any party violating any of the provisions of this chapter shall be guilty of a violation and, upon conviction thereof, shall be punished by a fine not to exceed the sum of \$250 for the first offense. A second offense shall be punishable by a fine not to exceed the sum of \$350 and a third offense shall result in the revocation of the Landscaper's permit for the next 6 (six) months, or, if you are the property owner, a fine not to exceed the sum of \$1,500. Any Landscaper found operating without a permit or after the permit has been revoked shall be punished by a fine of up to \$1,500.

Section 2. Severability.

The invalidity of any word, section, clause, paragraph, sentence, part or provision of this Local Law shall not affect the validity of any other part of this Local Law that can be given effect without such invalid part or parts.

Section 3: Effective Date.

This local law will take effect on January 1, 2022.

BACKGROUND:

The City Council has received a petition from Miriam Osborn Memorial Home Association ("The Osborn") to amend Chapter 197, *Zoning*, of the City Code to allow "Senior Living Facilities" ("SLF") in the City's R-2, *Single-Family Residence*, District. The petition submitted by The Osborn seeks to amend the text of the City Zoning Code to allow SLF in the City's R-2 District. The proposed amendment would allow SLF as a new permitted use in the R-2 Residence District on those properties with 50 or more contiguous acres. The proposed amendment also includes new restrictions and requirements regarding maximum floor area, building setbacks, lot coverage and other development standards.

As currently proposed, the amendment would only apply to property currently owned by The Osborn. This property is the only property currently located in the R-2 District that meets the proposed 50-acre minimum lot area requirement. Currently, The Osborn is regulated outside of the City Zoning Code by way of a Declaration of Covenants and Restrictions, dated October 15, 1993.

The proposed amendment would regulate land use at The Osborn to include new standards that would allow The Osborn to make improvements to its campus that the current Covenants and Restrictions do not allow.
