Re: City of Rye Emergency Services Cost for Playland Park

Date: July 30, 2021

As a follow up to our recent conversations, I have assembled the attached information related to the City's ongoing/regular emergency services support for Playland. The City's emergency services (along with the PC-R-RB EMS) are called upon throughout the year to provide assistance to the patrons and staff at Playland. This obviously has significant financial and operational implications for the City, which will only increase as you move to year-round operations. Since the Park has not been a property taxpayer to date, the weight of this obligation has been born by our residents, versus the park operator(s) and visitors.

The attached material is a simplified approach to the direct costs currently being borne by the City. As you will note, it does not include allocated administrative expenses, maintenance, depreciation of equipment, etc.; all of which will need to be considered. However, I do believe the information will give you a sense of the magnitude of cost. I am reviewing an analysis commissioned by the Town of Goshen regarding Legoland as a relevant approach and one that may be helpful to us both as we advance our discussion.

With regard to the impact on the City's sewer infrastructure, I am in the middle of analyzing the flow data highlighted when we met last. By my preliminary estimates, Playland is approximately 5-6% of the City's total water flow annually (billed through Suez). This discharge percentage should be considered a proportionate share of our sanitary sewer infrastructure cost and maintenance expense. Based upon an assumed annual sewer expense of approximately \$500k, Playland's allocated cost should be \$25-30k. As I mentioned in our meeting, we are expecting that cost to rise to as much as \$1.5mm annually as the City updates/modernizes our system in the next few years, translating into a cost to Playland of approximately \$75-90k. These numbers are estimates, and will need to be updated/refined, including proper cost allocations, but this should give us a good starting point for our upcoming discussions.

One final note, I am gathering more information on the current assessed value of Playland and will provide you with more information as it becomes available. Certainly, any resulting property tax amount would be significantly greater than our estimated cost of service, including the proportionate school taxes.

I look forward to continuing our conversations and appreciate your engagement to date.
