RESOLUTION OF THE RYE CITY COUNCIL TO ADOPT A NEGATIVE DECLARATION UNDER THE STATE ENVIRONMENTAL QUALITY REVIEW ACT (SEQRA) AND ADOPT A COASTAL CONSISTENCY DETERMINATION IN CONNECTION WITH THE CONSTRUCTION OF A SYNTEHTIC TURF FIELD AT NURSERY FIELD

WHEREAS, in 2019 a group of residents inquired whether the City would be willing to consider modifications to improve the playability of Nursery Field located at 421 Milton Road if the group donating the money; and

WHEREAS, the Rye City Council asked the Recreation Commission to consider the field choices and which field was best suited for a synthetic turf field and ultimately engaged consulting engineers to study potential improvements to Nursery Field; and

WHEREAS, between the fall of 2019 through February 2020, the City Council received a variety of reports and information from its consultants and staff regarding the viability and feasibility of various improvement options and turf choices to improve the playability of Nursery Field; and

WHEREAS, the information presented to the City included statistics showing that Nursery Field currently experiences a 40% cancellation rate due to rain events; and

WHEREAS, all reports and information were made available to the public on the City website; and

WHEREAS, the historical information regarding the City's prior review and consideration of Nursery Field when the property was originally modified to construct a field was also considered; and

WHEREAS, in 2002, the City Council adopted a negative declaration for the original improvements to the property to create a grass athletic field; and

WHEREAS, there was extensive comment both for and against various field improvement options presented at City Council meetings and in numerous written submissions from area neighbors, field user groups, the City's Recreation Commission, City Board and Commission members, community groups and organizations and the general public; and

WHEREAS, there were two public work sessions held in February 2020 in which the City Council heard consultant presentations and public comment regarding a variety of improvement options and playing surfaces; and

WHEREAS, the City Council suspended consideration of Nursery Field improvements as a result of the Covid-19 pandemic;

WHEREAS, the City Council held additional public meetings on May 24, 2023, and June 14, 2023, and heard consultant presentations and members of the public regarding the possible installation of turf at Nursery Field; and

WHEREAS, on June 14, 2023, the Rye City Council adopted a resolution directing staff to engage consultants to prepare drawings and relevant studies for the environmental and regulatory review for the proposed construction of a synthetic turf field to replace the existing grass athletic field at Rye Nursery located at 421 Milton Road (the "June 14 Resolution"); and

WHEREAS, the installation of turf at Nursery Field is subject to review under the State Environmental Quality Review Act (SEQRA); and

WHEREAS, in the June 14, 2023 Resolution, the City Council declared its intent to be Lead Agency for the environmental review of an identified proposed action defined as the construction of a synthetic turf field with a playing surface elevated above the 100-year FEMA flood elevation, including a robust sub-surface drainage system and an appropriate field base and infill material that is sensitive to the health and safety of field users and that does not significantly adversely impact the environmental functions of adjacent wetlands (the "Proposed Action"); and

WHEREAS, the City Council's June 14, 2023, Resolution also directed City staff and its consultants to prepare an Environmental Assessment Form (EAF), Coastal Assessment Form (CAF) and relevant studies and information as required by SEQRA; and

WHEREAS, the Proposed Action by the Lead Agency was initially classified as a Type I action pursuant to §617.4(b)(9) due to the location of the project adjacent to the Knapp House (which is identified on the National Register of Historic Places) and the preliminary estimate that the Proposed Action may disturb more than 2.5-acres of property; and

WHEREAS, based on the development of more detailed plans and refinements in the project, total site disturbance associated with the construction of the field and related improvements is anticipated to be 2.3-acres, which is below the threshold for Type I action to §617.4(b)(9); and

WHEREAS, the Proposed Action as revised does not meet any of the thresholds for a Type I under SEQRA and is appropriately classified as an Unlisted Action; and

WHEREAS, the Proposed Action does not involve any discretionary approvals from any other state or local agency including the New York State Department of Environmental Conservation (NYSDEC), whose authorization for this project will be under ministerial SPEDES general permit GP-0-20-001 for stormwater discharges for construction activities; and

WHEREAS, since the Rye City Council is the only involved agency for the proposed Unlisted Action a coordinated review was not conducted; and

WHEREAS, the City Council's June 14, 2023, Resolution referred the completed documents to the City Planning Commission for its advisory coastal consistency opinion as required by §73-5.C, *Coastal Zone Management*, of the Rye City Code and for its advisory comments with respect to wetland impact considerations; and

WHEREAS, consistent with past practice and the City Council's resolution in June 2002 in which it explicitly exempted the modifications to Nursery Field from any formal review and approval process by the City's boards and commissions, the application is not subject to the requirements of the Rye City Zoning Code or Chapter 195 Wetlands and Watercourses as confirmed by the Rye City Building Inspector based on the legal analysis of the City's Corporation Counsel; and

WHEREAS, in September 2023, the Rye City Planning Commission and Rye City Council received from the City's consultants a draft Coastal Assessment Form, draft EAF with supporting narrative and related studies and plans to assist in the review of the Proposed Action; and

WHEREAS, copies of all documents and information were made available to the public on the City's website and at the Rye Free Reading Room; and

WHEREAS, the Planning Commission conducted four public meetings between October and November 2023 in which it reviewed and discussed substantial written public comment, consultant presentations, plans, supporting studies and the entire record; and

WHEREAS, during the course its review the Planning Commission reviewed the consistency of the Proposed Action with each of the 44 policies of the City's LWRP and prepared a November 21, 2023 memorandum to the City Council of its advisory opinion that the Proposed Action is consistent with City's LWRP and Chapter 73, *Coastal Zone Management*, of the Rye City Code; and

WHEREAS, on November 8, 2023, the City Council scheduled a public comment period to be held on November 29, 2023, and reminded the public that anyone wishing to submit public comments in writing could do so; and

WHEREAS, on November 29, 2023, the City Council allowed several hours of public comment providing everyone wishing to be heard an opportunity to speak, had its professional consultants at the meeting to address the City Council's questions as well as the public's questions, and started reviewing the EAF and CAF; and

WHEREAS, on December 6, 2023, the City Council allowed additional public comment and continued and completed its review of the EAF and CAF, discussed issues relating to flooding, wetlands, other environmental and health factors, historic and community character, among other concerns; and

WHEREAS, the material components of the synthetic turf field to be constructed will have been tested for purposes of California's Proposition 65 standards and found to require no warning labels; and

WHEREAS, SEQRA requires the Lead Agency to consider the relative impacts based on the proposed changes as compared to the existing use and impact of the property; and

WHEREAS, the City Council has had before it and available to the public a library of information, including, but not limited to:

- February 27, 2020, and February 29, 2020, Nursery Field Work Sessions;
- Cover letter and EAF parts 1 & 2, and EAF Narrative, Figures and Maps;
- LWRP Application;
- Floodplain Management Forms;
- Nursery Field plans (as revised between meetings);
- Hydrologic Analysis;
- SHPO Determination (both March 2020 and October 2023);
- Soil boring memo;
- Consultant and Staff Presentations for the October 10, 2023, and October 24, 2023 Planning Commission meetings (Ramboll, Vision Sports and GZA);
- City Planning Commission memo to City Council;
- City consultant letter re PFAS;
- The County of Westchester Comments dated November 28, 2023;
- All additional documentation posted on the City's website accessible at: https://www.ryeny.gov/services/projects-and-information/nursery-field-project-information;
- Hours of public comment and discussion at the City Council with its professional consultants and staff; and

WHEREAS, it is the Council's understanding that the Proposed Action will be funded through the donation(s) of a not-for-profit organization, and it is the intent of the Council to accept the donations prior to the City awarding any bid for the construction of the Proposed Action; and

WHEREAS, once acceptable bid(s) have been vetted by the City, the City Council will award such bid(s) contingent upon the receipt of funds by donor group prior to such award.

NOW, THEREFORE, BE IT RESOLVED, as follows:

- 1. The recitations set forth above are incorporated in this Resolution as is fully set forth and adopted herein.
- 2. The City Council hereby finds and determines that:

- a) It has had all the records set forth above before it regarding the Proposed Action, reviewed the environmental assessment form (criteria set forth in 6 NYCRR Section 617.7(c)), thoroughly analyzed the relevant areas of potential environmental concerns, considered reasonable alternatives to the proposed action and has duly considered all the potential environmental impacts and their magnitude in connection with the Proposed Action; and
- b) The proposed construction of a synthetic turf field to replace the existing grass athletic field at Rye Nursery located at 421 Milton Road will not result in any large and important environmental impacts, and therefore, will not have a significant adverse impact on the environment.
- 3. It has had before it the City Planning Commission's advisory opinion on LWRP consistency and finds that the Proposed Action is consistent with the LWRP policies.
- 4. The reasons supporting both determinations are set forth on the attached in the State Environmental Quality Review Negative Declaration and Coastal Zone Management Waterfront Consistency Review Coastal Consistency Determination, which were reviewed and considered by the Lead Agency.

Re: Request for new Police Patrol Boat

Reference is made to the captioned subject, I am requesting funds be provided for the purchase of a new patrol boat for the Rye Police Department.

The current primary patrol boat (PB1) was built in 2001 and has been in service with the Police Department for 22 years. The vessel has surpassed its serviceable life and currently has the following problems:

- The engines have approximately 3000 hours on them and are due for replacement. It is expected this will cost approximately \$60,000
- The cabin is not enclosed and does not support year round operations
- The electronics and navigation equipment are outdated and obsolete and will need to be replaced at an expected costs of \$25,000-\$50,000

We have identified a suitable replacement for the current patrol boat and secured an estimate of \$587,000 with an expected delivery time of 16-18 months if ordered prior to January 01, 2024. After January 01 the price will increase by 10%. The proposed boat will be suitable for year-round operations and should have an expected useful lifespan of 20 years with regular maintenance / engine overhauls. Nearly identical boats are currently in use or being purchased by neighboring communities and are suitable for use in Long Island Sound in most weather conditions. I have attached a quote for the purchase.

SAFE Boats International, LLC ("SBI"), for the time periods detailed in the table below warrants that 1) all SBI manufactured products conform to SBI's specifications and are free of any defect in materials or workmanship; and 2) all SBI provided equipment has been properly installed. The coverage period is measured from the date of acceptance of the vessel. Original Manufacture Equipment is warranted by the respective manufacturer. Consumer understands that SBI's Limited Warranty, as well as its exclusions and limitations are factors in the determination of the contract price. Consumer has chosen to accept the Express Limited Warranty limitations rather than seek additional warranties and remedies at an increased price.

SBI's Express Limited Warranty, as well as any other warranty that might be expressed herein provided by SBI, only applies to the original consumer, as defined below, and it is non-transferable under any circumstances unless written consent is provided by SBI at SBI's sole discretion and assessment of the vessel's condition, if deemed necessary.

The Consumer's sole and exclusive remedy under this Limited Warranty will be repair or replacement of the warranted part, at SBI's sole discretion and assessment of the vessel's condition, if deemed necessary.

None of these warranties are valid for systems that have been modified or structurally altered or subject to unreasonable use, improper docking or storage, lack of reasonable and proper maintenance, negligence, or accident.

DEFINITIONS FOR TERMS WITHIN THIS WARRANTY

HULL- Welded aluminum structure from the deck to the keel of the Vessel.

SUPERSTRUCTURE- Any welded aluminum structure above the Vessel's deck or attached to the hull, including but not limited to the cabin, center console, bolsters, lockers, performance wings, and all parts permanently integrated into these structures, including windows and doors. Superstructure only includes those items manufactured by SBI that are permanently integrated into the superstructure, and specifically excludes all OEM components.

COLLAR SYSTEM- Outer collar membrane and internal foam.

ORIGINAL EQUIPMENT MANUFACTURER ("OEM")- The Vessel's engines, engine components, batteries, propellers, controls, control cables, steering systems, electronics, trailers, and any other accessory covered by a separate OEM warranty.

ORIGINAL CONSUMER- The original customer that purchased the Vessel directly from SBI.

The above stated warranty periods for services may be increased strictly upon purchase and registration through "Optional Service Plus" Warranty coverage with SBI. The "Optional Service Plus" Warranty only increases the duration/period of time which the components are covered. All

other responsibilities/obligations remain the same as contained within this Express Limited Warranty. Contact SBI Sales Department to obtain coverage and prices for "Optional Service Plus" Warranty period.

4. INSTALLED EQUIPMENT WARRANTED BY OEM

No warranty repairs are to be carried out without the expressed written authorization of SBI. SBI must be notified, in writing, within 30 days of the discovery of any defect which is subject to warranty by SBI. Warranty work may be performed at SBI's manufacturing facility, the Consumer's location, or the facility of an authorized SBI agent. If warranty repairs are to be performed at the Consumer's location, it is the responsibility of the consumer to make the vessel available to SAFE Boats at a suitable facility and the Consumer is responsible for all costs and logistics related to haul out, trailering and delivering the boat to the facility.

6. WARRANTY CLAIMS AND PROCEDURES

a) To be entitled to rights under the Express Limited Warranty, the Consumer shall submit a warranty claim request by contacting SBI's Warranty Department by phone or email within thirty (30) days after discovering a suspected defect, but in any event prior to the expiration of the applicable Warranty Period. Following receipt of such Consumer notice, SBI will work with the Consumer through photographs and dialog to make a provisional warranty determination. If SBI determines that the problem is likely covered by the Express Limited Warranty, SBI will authorize repair or replacement of the defective component by issuing a provisional warranty approval. Components that the Consumer claims to be defective shall be available to SBI for inspection and testing.

- b) In the event SBI determines an SBI-manufactured part or component is covered by SBI's Express Limited Warranty, SBI will pay for ground domestic return shipment of the repaired or replacement part to the Consumer if the faulty product is shipped to the SBI's factory. SBI bears the risk of loss or damage while the equipment or component is in transit to the Consumer from SBI's service center, and the Consumer bears the risk of loss or damage while the equipment or component is in transit to the SBI service center.
- c) Upon receipt of replacement equipment or component, the Consumer has thirty (30) days to return the defective equipment or component to SBI for actual warranty determination. If the Consumer does not return the defective equipment or component within the prescribed time, the Consumer shall pay to SBI the list price of such equipment or component, plus applicable shipping. Such failure to return the equipment or component may at SBI's discretion, be grounds for termination of the warranty and/or suspension of any future advance exchange privileges until such outstanding defective equipment or component has been returned.
- d) All defective equipment or components replaced by SBI become the property of SBI.

7. WARRANTY EXCLUSIONS

To the full extent permitted by law, SBI does not warrant or guarantee, and is not responsible for:

- a) Defects, failures, damages or performance limitations caused in whole or in part by 1) Use of non-SBI parts in warranty repair, 2) welding on or of the hull or superstructure, 3) any alteration in the collar system, 4) any work performed on a fuel tank, 5) permanently attaching any structure to the deck, hull, and/or superstructure other than original equipment parts, and 6) creating holes, welding, or cutting into/on the deck, superstructure, or collar system. Any of these actions will void the Warranty of the altered system unless explicitly approved in writing by SBI.
- b) Effects and failures due to accident, collision, or impact, use of unsuitable parts or add-on items, use of unauthorized parts, shipping damage, neglect, negligence, normal wear and tear, and/or damage due to combat or warfare. SBI's sole obligation under this Express Limited Warranty shall be to repair any defective material or workmanship covered by this Express Limited Warranty.
- c) Moorage fees, dock fees, launch or recovery, crane services or hoisting.
- d) Alterations and modifications of any component of the vessel without first obtaining the written authorization of SBI.
- e) Tears, fading, discoloration, deterioration, damage, or mildewing of curtains, cushions, tops, headliners, cockpit, sole covers or other fabric or upholstered components.

- f) Blistering, fading, chalking, or cracking of any paint, or metallic finish, minor cosmetic defects, and air voids.
- g) Electrolysis, galvanic corrosion, crevice corrosion or any other deterioration of underwater components. Any damage or deterioration to any metal surface (above or below the water line), including but not limited to painted metal or stainless-steel finishes or zinc anodes.
- h) Statements, advertising, or representations that estimate the speed, weight, fuel consumption and other performance characteristics of the vessel.

These eligible ordering entities are now authorized to access all Federal Supply Schedules for the purchase of supplies and services when expending federal grants funds in response to Public Health Emergencies (PHEs) declared by the Secretary of Health and Human Services under section 319 of the Public Health Services Act, codified at 42 U.S.C. § 247d.

1122 Counter-Drug Program

Section 1122 of the fiscal year 1994 National Defense Authorization Act established the authority for states and units of local government to purchase law enforcement equipment through federal procurement channels, provided that the equipment is used in the performance of counter-drug activities. The "1122 Program" affords state and local governments the opportunity to maximize their use of taxpayer dollars, by taking advantage of the purchasing power of the federal government to receive discounts commensurate with large volume purchases.

The governor of each state participating in the 1122 Program designates a <u>State Point of Contact (SPOC)</u> to administer the state's activities under the program, by validating the counter-drug mission of each procurement request, and ensuring the availability of funds. Contacting your SPOC is the first step to utilizing this program.

LOCAL LAW NO. _____-2023

A LOCAL LAW TO AUTHORIZING A PROPERTY TAX LEVY IN EXCESS OF THE LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-C

Be it enacted by the City Council of the City of Rye as follows:

Section 1. Legislative Intent

It is the intent of this local law to allow the City of Rye to adopt a budget for the fiscal year commencing January 1, 2024 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

Section 3. Tax Levy Limit Override

The City Council of the City of Rye, County of Westchester, is hereby authorized to adopt a budget for the fiscal year commencing January 1, 2024 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

Letter Agreement

This letter agreement (this "Agreement") is entered into as of December _____, 2023, by and between the Rye Youth Athletic Foundation, Inc., a Delaware corporation, ("Payor") and the City of Rye ("Recipient").

WHEREAS, the Recipient seeks to implement a restoration, improvement and resurfacing project to construct a synthetic turf field to replace the existing grass athletic field at Rye Nursery as generally described in the GZA document "Nursery Field Improvement Project" (the "Field Construction");

WHEREAS, the Payor is a nonprofit formed by private citizens to raise money, awareness and support for the Rye Recreation Department in their efforts to bring more usable outdoor play spaces to Rye, including the addition of turf fields;

WHEREAS, the Payor seeks to raise funds to be donated to the Recipient for purposes of the Field Construction;

WHEREAS, the Recipient intends to solicit bids or quotes from third-party contractors to undertake components of the Field Construction (each, a "Bid"); and

NOW, THEREFORE, in consideration of the foregoing and the mutual obligations set forth herein, the parties hereto, intending to be legally bound, hereby agree as follows:

1. Conditional Payment. Prior to the date on which the Rye City Council formally accepts a Bid (the "Winning Bid(s)") for the Field Construction the "Payment Date") and subject in all respects to the satisfaction of the conditions set forth in Section 2 (the "Conditions"), Payor shall provide funding to Recipient in an amount (the "Funding Amount") equal to the lesser of (A) \$3 million and (B) the sum of the amount set forth in the Winning Bid(s) and reasonable and documented "soft costs" (e.g., the professional fees paid by the Recipient for the plans necessary to permit Field Construction) associated therewith previously and incurred by the Recipient through the Payment Date (the "Soft Costs"). Payor agrees that the Soft Costs include, but are not limited to, the following amounts to date (with documentation to be provided): 1) costs incurred as of December 6, 2023, for consultant review and project design in an amount of approximately \$290,000; 2) costs authorized for 100% construction design authorized on December 6, 2023 and estimated to be in an amount up to \$100,000; and 3) anticipated construction management/oversight of Field Construction as agreed and documented prior to the Payment Date (which is estimated to be \$230,000). Payor shall transfer the Funding Amount to Recipient in U.S. dollars and in immediately available funds by wire transfer to a bank account or accounts designated by Recipient at least two business days prior to the Payment Date. Payor shall have no obligation to pay the Funding Amount prior to the Conditions being satisfied. For the avoidance of doubt, Soft Costs shall not include costs associated with any Litigation Action. The acceptance of the Winning Bid(s) is at the sole discretion of the City Council and the work for the Field Construction shall be overseen by the City of Rye or its designee. For the avoidance of doubt, the delivery of the Funding Amount shall be contingent upon the acceptance of a Winning Bid(s), and the parties shall use escrow or other arrangements reasonably necessary to ensure the City

of Rye has access to the Funding Amount upon acceptance of the Bid(s) and that the Funding Amount is not transferred to (or retained by) the City of Rye in the event the City of Rye does not accept a Bid(s).

2. Conditions.

- 1. No Litigation. There has not been, and there shall not have been, any civil, criminal, or administrative action, suit, claim, hearing, arbitration, investigation, audit or other proceeding (each, a "Litigation Action") pending or commenced (and not conclusively resolved) during the period commencing on the date of this Agreement, and lasting until the Payment Date, which, in the sole and reasonable discretion of Payor, would be reasonably expected to (x) result in the prevention of the Field Construction or the material delay of the Field Construction or (y) otherwise prevent the Field Construction from occurring in an orderly manner.
- 2. No Actions by Recipient. During the period commencing on the date of this Agreement, and lasting until the Payment Date, there has not been, and there shall not have been, any action (which has not conclusively resolved) by the Rye City Council, any employee of City of Rye or any committee associated with the City of Rye or any other federal, state or local governmental authority (including, for the avoidance of doubt, any employee of or any committee associated with such other governmental authority) that, in the sole and reasonable discretion of Payor, would be reasonably expected to (x) result in the prevention or material delay of the Field Construction or (y) otherwise prevent the Field Construction occurring in an orderly manner.
- 3. Other Actions. Any other actions (by Recipient or any other persons), facts or circumstances (which have not been conclusively addressed or resolved) which, in the sole and reasonable discretion of Payor, would be reasonably expected to (x) result in the prevention or material delay of the Field Construction or (y) otherwise prevent the Field Construction occurring in an orderly manner.
- 4. Funding. Payor shall use best efforts to raise the Funding Amount. Payor's obligations under this Agreement are subject to Payor successfully raising the Funding Amount, and nothing in this Agreement shall be interpreted to bind Payor to raise the Funding Amount.
- 3. <u>Recipient Commitment</u>. Upon receipt of the Funding Amount, Recipient agrees to use best efforts to complete the Field Construction in a timely and orderly fashion and to not take any action that would reasonably be expected to delay or prevent (or fail to take any action that would reasonably be expected to facilitate or accelerate) Field Construction.
- 4. <u>Litigation Actions</u>. Recipient agrees not to seek defense costs from Payor to defend itself against any Litigation Action relating to the Field Construction. Similarly, Payor agrees not to seek defense costs from Recipient to defend itself against any Litigation. For the avoidance of doubt, each party shall bear its own litigation defense costs.

- 5. Material Delays. If in the reasonable judgment of the Payor, the Field Construction will not have commenced by October 31, 2024, as a result of (A) any Litigation Action, (B) any action by the Rye City Council, any employee of Recipient or any committee associated with Recipient or any other federal, state or local governmental authority (including, for the avoidance of doubt, any employee of or any committee associated with such other governmental authority), or (C) any other actions (by Recipient or any other persons), facts or circumstances (each, a "Material Delay"), Recipient agrees to return the Funding Amount to Payor in immediately available funds by wire transfer to a bank account designated by Payor.
- 6. Payor Remedies. In the event of a Material Delay or if the Field Construction will not move forward for any other reason, Payor and Recipient agree that Payor's sole remedy against Recipient is the return of the Funding Amount. Other than seeking the return of the Funding Amount, Payor is waiving any right(s) it may have to commence litigation against Recipient, the Rye City Council, any employee of City of Rye or any committee associated with the City of Rye in the event the Field Construction is not commenced by October 31, 2024.
- 7. <u>Further Assurances</u>. Each of the parties hereto shall execute such documents and perform such further acts as may be reasonably required or desirable to carry out or to perform the provisions of this Agreement.

8. Miscellaneous.

- a. *Amendments*. Any provision of this Agreement may be amended or waived if, and only if, such amendment or waiver is in writing and is signed, in the case of an amendment, by each of the parties hereto, or in the case of a waiver, by the party against whom the waiver is to be effective.
- b. *Entire Agreement*. This Agreement constitutes the entire agreement between the parties hereto with respect to the subject matter hereof and supersedes all prior agreements and understandings, both oral and written, between the parties hereto with respect to the subject matter hereof.
- c. *No Third-Party Beneficiaries*. No provision of this Agreement, express or implied, shall be construed to confer any rights, benefits, remedies, obligations, causes of action or liabilities hereunder upon any person, other than the parties hereto and their respective successors and permitted assigns.
- d. Severability. Each provision of this Agreement is severable. If any such provision, is held to be invalid, illegal, void or unenforceable, (a) it shall have no effect in that respect and the parties shall use their respective commercially reasonable efforts to replace it in that respect with a valid and enforceable substitute term, provision, covenant or restriction (as applicable), the effect of which is as close to its intended effect as possible; and (b) the remainder of the terms, provisions, covenants and restrictions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated so long as the economic or legal substance of the transactions contemplated hereby is not affected in any manner materially adverse to any party.

- e. Governing Law. This Agreement, any suit, action or proceeding seeking to enforce any provision of, or based on any matter arising out of or in connection with, this Agreement or the transactions contemplated hereby, shall be governed by and construed in accordance with the laws of the State of New York, without regard to the conflicts of law rules of such state.
- f. Counterparts. This Agreement may be signed in any number of counterparts, and by each party on separate counterparts. Each such counterpart shall be an original, with the same effect as if the signatures thereto and hereto were upon the same instrument. Delivery of a counterpart hereof by e-mail attachment shall be effective as delivery of a manually executed original counterpart of this Agreement.

Subject: Contract 2023-06 – Fuel Tank & System Replacement

The bid opening for the above contract took place on December 13, 2023. A copy of the bid results is attached.

I have checked and tabulated the two bids submitted and hereby recommend that the bid be awarded to American Petroleum Equipment & Construction Co., Inc. in the amount of Four Hundred Seventy-Six Thousand, Three Hundred Thirty Dollars and Zero Cents (\$476,230.00). APECC currently services our fueling station.

American Petroleum Equipment & Construction Co., Inc. was the lowest responsive and responsible bidder for this contract.

The original funds provided for this project totaled \$350,000 and included the replacement of the underground tanks with an above ground tank. Due to new regulatory requirements, the project scope changed to replacement of the underground tanks inkind. The City previously purchased \$72,879.80 for a updated fuel management system, tank monitoring system and dispensers under a Sourcewell Contract. These items will be installed under this project.

There is approximately \$277,120. available in the Fuel Tank & System budget.

We are requesting an additional \$200,000 be allocated to complete this project. There may be some cos-saving opportunities with pavement replacement and site restoration that could be performed by DPW staff to reduce costs at which time any unused funds would be returned to the General Fund.

BACKGROUND: Each year the City of Rye financially supports the operations of the Rye Free Reading Room (RFRR). In FY 2023, the contribution was in the amount of \$1,360,000. The attached agreement for FY 2024 includes an appropriation of \$1,385,000. The agreement stipulates the specific rights and obligations of both parties, pursuant to section 256 of the Education Law of the State of New York.

THIS AGREEMENT, made as of the _____day of December, 2023, by and between the CITY OF RYE, a municipal corporation located within the County of Westchester and State of New York, party of the first part, and RYE FREE READING ROOM, a free library association duly registered by the Regents of the University of the State of New York at a meeting thereof on January 24-25, 1917, and maintaining a free library in the City of Rye, County of Westchester and State of New York, party of the second part:

<u>WITNESSETH</u>, that the parties hereto, pursuant to section 256 of the Education Law of the State of New York, do hereby mutually covenant and agree as follows:

- 1. The party of the second part does hereby agree to furnish library privileges to the people of the City of Rye, under reasonable rules and regulations of the party of the second part, during the terms of this agreement.
- 2. The party of the second part does hereby agree that the Rye Free Reading Room will make all best efforts to offer service to the public a minimum of 47 hours in the winter and 47 hours in the summer. The Library will make all best efforts to ensure that within its hours of operation that Saturday is open. In addition, the Rye Free Reading Room will guarantee that they will be open for "special events" in accordance with the policies and procedures of the library as they occur throughout the year.
- 3. The party of the second part does hereby agree to submit to the City of Rye a financial report within two months of the close of its fiscal year and to provide copies of an annual narrative report prepared for association members. Copies of all audit reports prepared by independent audit firms or the State of New York will be filed, within 30 days of receipt, with the City Comptroller and the City Council's Audit Committee.
- 4. In consideration of the foregoing the party of the first part does hereby agree to pay the sum of One Million Three Hundred Eighty Five Thousand Dollars (\$1,385,000) to the party of the second part during the calendar year: Six Hundred Ninty Two Thousand Five Hundred Dollars (\$692,500) to be paid in January, and Six Hundred Ninty Two Thousand Five Hundred Dollars (\$692,000) to be paid in July.
- 5. Pursuant to said statute, such total sum shall be a charge upon the City of Rye and shall be raised, appropriated and paid in the same manner as other City charges.

- 6. If the capital improvements that were part of the 2012 bond resolution are installed in 2024, the Rye Free Reading Room will be responsible for all maintenance and repair costs of same.
- 7. The Rye Free Reading Room will continue to abide by the Memorandum of Agreement between the City of Rye and the Rye Free Reading Room dated November 30, 2021, for the operation of the public component of RyeTV.
 - 8. This agreement shall be effective and continue for the calendar year 2024.

THE COUNTY OF WESTCHESTER, a municipal corporation of the State of New York, having an office and place of business in the Michaelian Office Building, 148 Martine Avenue, White Plains, New York, 10601,

(hereinafter referred to as the "County"),

and

THE CITY OF RYE, a municipal corporation of the State of New York having an office and place of business at 1051 Boston Post Road, Rye, New York, 10580,

(hereinafter referred to as the "Municipality," and collectively with other signatory municipalities, as the "Municipalities" or "Signatory Municipalities").

WHEREAS, the purpose of the Mutual Aid and Rapid Response Plan for the Police Departments of Westchester County, New York (the "Plan") is to formalize operational procedures for Law enforcement assistance to participating agencies; and

WHEREAS, the Signatory Municipalities have executed the Plan by which each member agrees to make available its police personnel and equipment to the others upon the occurrence of a condition which is beyond the scope of its police resources; and

WHEREAS, due to prevailing world, national and local security situations, the ever increasing flow of intelligence, and actual threats directed against once benign sites and facilities, the parties desire that the Plan be flexible and subject to review and revision as necessary in a timely manner; and

WHEREAS, the Signatory Municipalities desire, <u>inter alia</u>, to ratify and execute this Agreement in order to effectuate the Plan and to agree on the procedures for timely review and revision of the Plan; and

WHEREAS, said Plan is governed by and liabilities and costs are apportioned pursuant to the provisions of New York State General Municipal Law ("General Municipal Law") Section 209-m which provides, inter alia, that absent agreement to the contrary, the municipality receiving police aid (the "Requesting Municipality") shall reimburse the municipality providing such aid (the "Assisting Municipality") for any money paid by it for police salaries and other expenses incurred by it including damage to, or loss of, equipment and supplies.

NOW, THEREFORE, in consideration of the terms and conditions herein contained, the parties agree as follows:

FIRST: Definitions

- (1) <u>Chief Executive Officer:</u> The officer within a Signatory Municipality who is authorized pursuant to General Municipal Law Section 209-m to request or grant a request for police assistance from another Signatory Municipality.
- (2) <u>Department Head</u>: Any police chief, Commissioner or other official in command or acting command of the police department or police force of a Signatory Municipality.

- (3) <u>Requesting Municipality</u>: Any Signatory Municipality requesting the assistance of the police force of another Signatory Municipality pursuant to the terms of this Agreement.
- (4) <u>Assisting Municipality</u>: Any Signatory Municipality providing assistance to a Requesting Municipality pursuant to the terms of this Agreement.
 - (5) Emergency: Shall have its common dictionary definition.
- (6) <u>Signatory Municipality</u>: All municipalities that have signed this Agreement, including the County.

SECOND: A true and accurate copy of the Mutual Aid and Rapid Response Plan for the Police Departments of Westchester County, New York (hereinafter the "Plan"), is annexed hereto and incorporated herein as Schedule "A". The Parties further agree to the Plan, as it may be amended from time to time, in accordance with the review and revision procedures set forth in said Plan and this Agreement.

THIRD: This Agreement shall commence on July 31, 2020 (the "Commencement Date") and terminate on July 30, 2025, unless terminated sooner in accordance with the provisions hereof. Any prior agreement signed by a Signatory Municipality for this purpose shall be deemed terminated upon the commencement of this Agreement.

FOURTH: The Signatory Municipalities hereby agree to render appropriate police services, in accordance with the Plan, to any Requesting Municipality whenever

the Chief Executive Officer of that municipality deems the general public interest requires it. All such requests for assistance shall be made by the Chief Executive Officer or Department Head of the Requesting Municipality and granted by the Chief Executive Officer or Department Head of each Assisting Municipality as set forth in the Plan.

<u>FIFTH</u>: The cost of police services provided pursuant to this Agreement shall be paid by the Requesting Municipality subject to the following exceptions:

- (a) The police services provided by the County shall be without cost to the Requesting Municipality.
- (b) The police services provided by each Assisting Municipality shall be reimbursed as provided in Section 209-m of the General Municipal Law, as same may be amended, except as provided above in Paragraph (a).
- (c) The Requesting Municipality shall reimburse the County and each Assisting Municipality for all liability for damages arising out of acts performed by the Assisting Municipality in rendering aid. In addition, the Requesting Municipality shall provide defense for and defend, at its sole expense, any and all claims, demands or causes of action directly or indirectly resulting from the rendering of aid by the County and each Assisting Municipality. Notwithstanding the foregoing, the Requesting Municipality shall not be liable for any damages resulting from any intentional wrongs or reckless conduct by the police force of the Assisting Municipality.
- (d) The requesting Municipality shall reimburse the County and each Assisting Municipality for all expenses incurred pursuant to the provisions of Section 207-c of the

General Municipal Law, as same may be amended, and for any award of compensation made pursuant to the Workers' Compensation Law for salaries and expenses paid to officers of the County and each Assisting Municipality who are injured while rendering assistance to the Requesting Municipality pursuant to the Agreement.

SIXTH: Any party to this Agreement may withdraw at any time, upon thirty (30) days written notice to each of the other Signatory Municipalities, and thereafter such withdrawing party shall no longer be a party to this Agreement, but this Agreement and the Plan shall continue to exist among the remaining parties and Signatory Municipalities.

SEVENTH: (a) The Westchester County Chiefs of Police Association ("WCCOPA") shall be responsible for the administration and future amendments or revision of the Plan. Administration shall entail, but not be limited to, the development of an organized effort, identification of county-wide special equipment, the addition or removal of participating municipalities or police departments to the Plan, whether they operate within or outside of the physical boundaries of Westchester County, and interface with auxiliary services and agencies for the development of protocols and assumed responsibilities;

- (b) A sub-committee of the WCCOPA will review the Plan at least once a year and formulate recommendations for amendments or revisions as necessary; and
- (c) In order to effectuate the purposes of this Section and to authorize WCCOPA to determine the operational details of the Plan without need for legislative authorization

each time an amendment to the Plan is required, the Municipality represents and warrants that its representative(s) at WCCOPA is/are duly authorized to administer the Plan and to authorize any and all revisions to the Plan on behalf of the Municipality.

EIGHTH: The rights and obligations set forth in this Agreement shall be binding upon and shall inure to the benefit of each municipality which has executed this Agreement with the County.

NINTH: As to any signatory municipality, this Agreement shall not be enforceable until signed by both parties and all applicable legal approvals have been obtained.

TENTH: If any term or provision of this Agreement is held by a court of competent jurisdiction to be invalid or void or unenforceable, the remainder of the terms and provisions of this Agreement shall in no way be affected, impaired, or invalidated, and to the extent permitted by applicable law, any such term, or provision shall be restricted in applicability or reformed to the minimum extent required for such to be enforceable. This provision shall be interpreted and enforced to give effect to the original written intent of the parties prior to the determination of such invalidity or unenforceability.

ELEVENTH: All notices of any nature referred to in this Agreement shall be in writing and either sent by registered or certified mail postage pre-paid, or sent by hand or overnight courier, to the respective addresses set forth below or to such other addresses as the respective parties hereto may designate in writing. Notice shall be effective on the date of receipt.

RESOLUTION OF THE CITY OF RYE CITY COUNCIL REGARDING PROCEEDINGS BEFORE THE PUBLIC SERVICE COMMISSION WITH REGARD TO PETITION BY VEOLIA WATER FOR INCREASE IN WATER RATES

WHEREAS, Veolia filed a petition for an increase in water rates with the New York Public Service Commission ("PSC") to increase rates by over 20% effective February 2024;

WHEREAS, for many years the Village of City of Rye, Village of Port Chester and Village of Rye Brook have worked together to present the strongest possible defense against these water cases; and

WHEREAS, such collective effort have included the joint retainer of a specialized attorney, Joel R. Dichter of Dichter Law LLC,, who advocated before the PSC and fully participated in the proceedings including presentation of an expert witness on our behalf;.

WHEREAS, a settlement has been reached between Veolia and Staff of the Public Service Commission that provides for a four year agreement with annual increases of 5.9% and substantially increases its annual investment to \$30 million in maintaining and improving the water system within Westchester.

WHEREAS, the agreement also dispenses with Veolia's proposal to harmonize rates in this case with those of New Rochelle, which would have resulted in substantially higher rates for City of Rye residents and provides for developers in Port Chester to contribute 80% of the cost of additional facilities to meet higher demands.

WHEREAS, the Village or Port Chester and Village of Rye Brook trustees have authorized signing of the Settlement, which is subject to Public Service Commission approval.

NOW, THEREFORE, BE IT RESOLVED, that the City Council authorizes Joel R Dichter to join on, and be a signatory to, the settlement agreement for the Veolia Water New York Rate Case pending before the New York Public Service Commission.

We are in the process of renovating both the Mayor's Conference room and the Annex Conference room. As part of the renovations, all new furniture has been ordered. We are requesting that the Council deem these items as "surplus" so that we can dispose of them in accordance with the City's surplus policy.

City of Rye – Surplus Policy and Procedures

While there is no state law requirement on the disposal of assets, at this time the City is implementing formal internal procedures for best practices in the disposal of assets. The City acts as a fiduciary for the taxpayer and commits to uphold complete transparency in the process.

This policy expands on the capital asset policy already in place, as it will include all assets with a purchase value of over \$500. The City will maintain a centralized comprehensive list of assets across all City departments, updated monthly and reviewed by the Comptroller.

From time to time, equipment, vehicles, or other assets become obsolete, damaged, in disrepair, or otherwise no longer provide useful value to the municipality. To address the disposal of these items, the City is adopting the following policies:

- 1) <u>Items to be declared as Surplus.</u> If a Department Head deems items to no longer be useful to the City, he/she **shall** submit an itemized list of such items to the City Council for approval. Examples (for illustrative purposes) of such items include, but are not limited to:
 - Items included on the comprehensive asset list;
 - Vehicles (e.g. police cars, front loaders, golf cars);
 - Professional Apparatus/Equipment (e.g., LIDAR detectors, Fire Department equipment, cameras, lawn/property maintenance tools/machines);
 - Any items estimated to have a current value of over \$500;
 - Any items that had a purchase price of over \$500 when purchased;
 - Equipment, gear or other materials acquired through the 1033 program
- 2) <u>Declaration of Surplus Items.</u> Each Department Head is responsible for submitting a list of items for surplus consideration to the City Manager's office on an as-needed basis. The City Council shall vote in a roll call to approve or deny the recommended items submitted from the City Manager as surplus. The memo shall provide an estimate on the current value of the item for consideration.
- 3) The resolution should read as follows:

- 4) <u>Disposal of Items.</u> Pursuant to the resolution, City staff has the authority to dispose of the surplus items in a manner consistent with the guidelines below, or any applicable policy or law If a best practice for disposal is uncertain, the preferred method of disposal is auctioning the item to ensure the chance of greatest financial return to the City. The manner for disposal shall be included in the memo from the Department Head to the City Manager. The methods for disposal are preferred in the following order:
 - Professional auction service (*Preferred method of disposal*)
 - Sale of asset for fair market value pursuant to a purchase and sale agreement approved by the City Manager and Corporation Counsel, should the auction service yield unfavorable results. A memo of explanation is required from the Department Head to the City Manager and Comptroller as to why the professional auction service was not used.
 - Proper disposal techniques for unique/unsafe items (i.e. police LIDAR and firearm apparatus). A memo of explanation is required from the Department Head to the City Manager and Comptroller as to the reason for the manner of disposal.
 - Donation to another government entity upon letter request. A memo of explanation is required from the Department Head to the City Manager and Comptroller as to why the professional auction service was not used and documentation by the receiving entity that such equipment/material is needed by it.
 - Discard damaged or other items of no value in appropriate trash receptacle or other appropriate waste removal methods. Documentation of damage and "no" value shall be prepared by Department Head with appropriate supporting information (e.g., pictures of damaged item, a "blue book" value or other relevant determination of value, inability to find necessary components to allow equipment to function).
 - Pictures of all items deemed surplus, regardless of disposal method, should be saved for one year to document the condition of the item when it left the City's possession.
